Mr. Robert Wong, Caltrans, updated the Committee on changes and additions to Caltrans staff.

ITEM 7 COUNTY OF VENTURA CONGESTION MITIGATION AND AIR QUALITY (CMAQ) PROGRAM REVISION – For Action

Ms. Judy Johnduff, indicated that the Sespe Street Project has encountered some right-of-way issues and will not be able to be constructed as originally intended. The proposed change in scope would not offer the benefits proposed in the County's initial CMAQ application for funding which was approved by the Commission. Staff's recommendation is to reprogram the CMAQ funds from the Sespe Street Project to the Rice Road Project.

Discussion:

The Committee discussed both reprogramming the funds and the proposed change in scope.

Chair Fleisch, indicated that the County would prefer the Committee approve a change in scope for the Sespe Street Project instead of reprogramming the funds.

Mr. Finley, City of Thousand Oaks, made a motion to approve the change in scope requested by the County and to revise the Wayfinding Study Route to utilize Pasadena Avenue as recommended by County Staff.

2) Active Transportation Program (ATP) – Cycle 4 Call-For-Projects:

- B. This call will cover FY 2019/20, FY 2021/22 with \$440 million in available funding,
- C. It is anticipated that the first two years of allocation will be SB 1 Funds which would be state funding only, which may be a consideration when selecting projects to submit for funding,
- D. Cycle 4 Guidelines, Applications, and high level Scoring Rubric are available now on the CTC Website (link was provided).

Also, it was mentioned, that there will be FIVE (5) different applications (a list was provided) and how the applications will be scored using a Scoring Rubric (a high-level Scoring Rubric table was provided) as example.

SUBJECT: UPDATE ON SENATE BILL 1 – IMPLEMENTATION

RECOMMENDATION:

Information Only

BACKGROUND AND DISCUSSION:

Senate Bill 1, the Road Repair and Accountability Act, signed into law on April 28, 2017, will provide \$54 billion over the next decade to fix roads, freeways and bridges and provide transit and safety improvements throughout California. The California Transportation Commission is responsible for allocating the funds which are split equally between state and local investments. An update is provided below on recent actions and important upcoming dates for the implementation of SB1.

SHOPP:

- At their March 21/22nd meeting the CTC approved the 2018 SHOPP. SB 1 added \$6.4 billion of programming capacity to the Four Year Cycle.

- The Project List for Ventura County starts on Page 277.

STIP:

- The CTC also approved the 2018 STIP at its March meeting.
- Due to reduced motor fuel prices, the 2016 STIP had eliminated \$750 million of programming capacity. Thanks to the provisions of SB 1 to stabilize fuel tax revenue based on CPI, the 2018 STIP added \$2.2 billion of new capacity, basically restoring the \$750 million and adding two year new years to the program with the anticipated associated funds.
- VCTC's submittal was only for the 5% share for \$2.08 million for Planning, Programming & Monitoring.

 VCTC currently has a \$58 million unprogrammed STIP share balance that will roll over to future STIPs. VCTC's policy is to prioritize those funds for construction of Route 101 Early Action items, with programming to occur after the environmental clearance is complete.

SUBJECT: STP LOAN OF \$12.5 MILLION TO ORANGE COUNTY TRANSPORTATION AUTHORITY

RECOMMENDATION:

Approve loan of \$12.5 million from the Ventura County Regional Surface Transportation Program
apportionment, approximately equal to the projected FY 2017/18 ending unobligated balance, to the
Orange County Transportation Authority 9OCTA), with the repayment to occur in FY 2022/23, the
earliest that it is expected to be needed for Route 101 final design.

BACKGROUND:

Under federal law, Surface Transportation Block Grant (STBG) funds apportioned to California lapse if they are not used within three years. By state law, California distributes a part of its STBG apportionment to counties by formula under the Regional Surface Transportation Program (STP). State law also applies the three-year lapsing rule to the STP apportionments of each county.

VCTC's policy is that the Route 101 improvement early action items project is the priority for STP funds as well as State Transportation Improvement Program (STIP) funds. The STP fund balance must therefore be carefully managed, to build up a large amount of funds that can be used when needed by the project, while at the same time avoiding a lapse of funds. The common practice that is used by a county wishing to build up a STP balance is to provide loans to other counties that are ready to use the funds, so it has been anticipated that VCTC will need to participate in such loans.

Last year VCTC loaned \$6 million to the San Joaquin Council of Governments, out of which \$3 million has been repaid per the agreed-upon schedule, and the remaining \$3 million will be repaid this coming November. In its approval of the San Joaquin loan, TTAC requested staff to return with a long-term schedule of STP expenditures to help plan for when lapsing funds would become an issue. This analysis was provided in September 2017.

Shortly after the September TTAC discussion staff informed the other counties in the SCAG region of VCTC's interest in loaning STP funds over the next several years, and the Orange County Transportation Authority indicated that it would likely have a need for a loan later in the fiscal year. OCTA has now informed VCTC that they indeed have this year two projects that will be ready to use as much as VCTC has available to loan.

OCTA would prefer that the loan repayment be scheduled no earlier than when VCTC is anticipated to require the funds.

DISCUSSION

Attachment A is an update of the analysis of future STP expenditures and balances that was first presented to TTAC in September. Attachment B provides a revised schedule showing the effect of the proposed loan to OCTA. Based on the remaining projects scheduled to be obligated this year (consisting of the Route 101 environmental document cost increase of \$3 million plus \$1,586,631 in resurfacing projects for Oxnard, Camarillo, and Port Hueneme), the anticipated balance at the end of the year will be \$21,633,049, so VCTC can loan up to this amount. For simplicity staff is recommending that the number be rounded down to \$21.5 million. Even with this loan, no later than FY 2020/21 VCTC will still need to loan an additional \$12.4 million to avoid lapsing funds. Since the earliest the Route 101 project is anticipated to obligate more funds is FY 2021/22, when PS&E commences, the repayment from OCTA is recommended to be scheduled for that year.

It should be noted that if as long as the Route 101 environmental document cost increase is obligated in FY 2017/18, there will be a no lapse of funds this year. However, a minimum of \$8 million will need to be loaned by the end of FY 2018/19. Given that approximately \$34 million must be loaned over time, it will likely be to VCTC's advantage to take any available opportunity to provide a loan, since VCTC cannot be certain when future loan future loan opportunities will become available. The proposed loan to OCTA will allow VCTC to address \$21.5 million of its \$34 million loan need, so that the future need to loan funds will be greatly reduced. In fact, the two ready-to-go projects in Orange County could accept even more loaned funds but VCTC does not have capacity in FY 2017/18 to loan any more.

As shown in the Attachment B schedule, as soon as VCTC receives its FY 2018/19 apportionment combined with the remaining \$3 million San Joaquin loan repayment, the balance will go back over \$10 million and remain over \$10 million until the funds are needed for 101. Therefore, although the policy is for Route 101 to have priority there would be flexibility should any unanticipated financial need arise, such as for example any additional costs for the Route 101 environmental document, or some unanticipated need for the Rice Bridge. (However, Caltrans' application for SB 1 Rice Bridge funding provides that the state will fully cover the unfunded amount from that project, including any future overruns.)

It should be noted that the recently-approved FY 2017/18 federal budget included a one-time increase in Surface Transportation Block Grant funding, above the authorized amount which has been the basis of VCTC's programming assumptions. Staff is still waiting for notification of the amount, if any, by which VCTC's allocation will increase. Any such increase in 2017/18 funds will require obligation in three years and so will result in an increase in the \$34 million total loan requirement.

The only risk to VCTC would be that in the event of a severe federal cutback the OCTA's apportionments would be cut and then the repayment from OCTA could be delayed. It is of course difficult to predict what federal changes could occur between now and 2022. However, since OCTA's apportionment is approximately \$40 million per year the cutback would have to be extremely large to prevent OCTA from repaying \$21.5 million to VCTC.
