SUBJECT: RICE AVENUE GRADE SEPARATION FUNDING

RECOMMENDATION:

• Approve programming of \$1.5 million of Regional Surface Transportation Program (STP) funds for the Rice Avenue Grade Separation final design.

BACKGROUND:

Within a few weeks the City of Oxnard will release the draft Environmental Document for the Rice Avenue Grade Separation project, with the final document expected to be completed in March 2018. This effort was primarily funded through \$1,760,000 in STP funds programmed by VCTC through a call for projects in 2012. Although VCTC and Oxnard worked with Caltrans to obtain a discretionary Federal Railroad Administration (FRA) grant for \$1,523,318 for final design of this project, no further funding has been committed to the project at this time. However, as has been discussed with TTAC and the Commission, the passage of SB 1 appears to provide an opportunity to obtain full funding for this project which is VCTC's top priority for goods movement projects. Caltrans has expressed a commitment to work with VCTC and Oxnard to submit an application for the project for the Trade Corridor Enhancement Program established under SB 1. According to the program's guidelines, applications are due January 30th, and funds will be made available to selected projects on May 16th.

The Attachment summarizes the project's currently-projected schedule, cost, and committed revenues. Upon completion of the environmental phase it will be possible to proceed with final design and right-of-way acquisition, which are anticipated to cost approximately \$15 million, of which \$1.5 million is committed through the FRA grant. VCTC is optimistic that the SB 1 funds will become available beginning in May but to show at least a minimal local commitment to the project and provide flexibility to keep the project moving prior to the SB 1 decision, staff recommends that VCTC commit \$1.5 million from the unprogrammed Regional STP apportionment balance to the project's final design phase. Approval of this \$1.5 million will leave an unfunded balance of \$68.3 million which is anticipated to be the SB 1 Trade Corridor funding request.

At the last TTAC meeting staff provided information regarding the STP balance and noted that at least \$1 million must be obligated beyond what is currently scheduled, to avoid a lapse. Obligation of \$1.5 million to the Rice Grade Separation should help to prevent a lapse of funds in FY 2017/18.

SUBJECT: TRANSPORTATION DEVELOPMENT ACT (TDA) ARTICLE 3 MAINTENANCE FUNDS

RECOMMENDATION:

BACKGROUND:

On March 4, 2016, the Ventura County Transportation Commission (VCTC) reaffirmed a long-standing policy to allocate of 25% of Ventura County's TDA Article 3 apportionment for Class 1 bicycle path maintenance based upon the number of Class I pathway miles within each jurisdiction. The table below shows the breakdown for FY16/17's allocations:

SUBJECT: STATUS OF 2019 TRANSPORTATION IMPROVEMENT PROGRAM

RECOMMENDATION:

· Receive and file.

DISCUSSION:

Federal law requires that federally-funded transportation projects, as well as regionally-significant projects funded with state and local funds be included in an approved Transportation Improvement Program (TIP). VCTC prepares Ventura County's portion of the TIP for the Southern California Association of Governments (SCAG). The TIP is required to be updated every two years and covers a period of not less than four years. The SCAG 2019 TIP will cover a 6-year period from October 1, 2018 (FY 2018/19) through September 30th of 2024 (FY 2023/24).

The first step in drafting the 2019 TIP is to obtain accurate up-to-date information for each project. Therefore, VCTC sent each jurisdiction a request to:

- 1. Update the project information currently listed on the 2017 TIP Project Sheets and,
- 2. Submit new Project Sheets for any new Federally-funded project or new locally funded regionally significant project through FY 23/24.
- 3. We are asking for the information to be submitted to VCTC between October 20th and November 1st. Once VCTC receives the project information we will enter the data into the SCAG database so that SCAG can start the adoption process.

The current TIP will still be in effect until the adoption of the 2019 TIP, therefore, staff will continue to process project amendments to the current TIP to accommodate changes in funding and project schedules.

SUBJECT: SENATE BILL 1 IMPLEMENTATION – ACTIVE TRANSPORTATION PROGRAM (ATP)

RECOMMENDATION:

Information Only

BACKGROUND:

Senate Bill (SB) 1, approved in April, appropriates \$100 million a year from the Road Maintenance and Rehabilitation Account (RMRA) to the Active Transportation Program (ATP) starting in fiscal year 17/18. In June, the California Transportation Commission (CTC) adopted guidelines to implement a mid-cycle program to award the first, two-years (FY 17/18 and FY18/19) of RMRA funding. Applications for the Cycle 3 Augmentation were due August 1st, 2017. Five (5) projects were submitted from Ventura County. Ventura County's population share under the MPO Component is approximately \$1.74 million.

DISCUSSION

On Thursday October 5, 2017, the SCAG Regional Council adopted the Augmented 2017 ATP Project List for the SCAG region. The list includes funding for three projects in Ventura County previously not selected under the Cycle 3 call for projects including:

- 1. The City of Ventura Harmon Barranca Corridor Gap Closure Project for Montalvo and Portola Elementary Schools.
- 2. The City of Thousand Oaks Conejo School Road and Willow Lane Safe Routes to Schools (SRTS) Sidewalk Improvement Project, and
- 3. The County of Ventura Potrero Road Bike Lanes Project Phase 1. The total request for ATP funding for this project was \$2,095,000. Ventura County's population share of the Augmentation funding is approximately \$1,740,000, therefore only \$467,000 of funding is available for this project which scored lower than the projects #1 and #2 listed above. The County of Ventura is proposing to use a combination of Congestion Mitigation and Air Quality funds (CMAQ) and Local Funding to complete the funding for this project.

Additionally, SCAG approved the City of Ventura's request to advance the design phase of the Montalvo SRTS Cypress Point Gap Closure and Complete Streets Project which was funded under Cycle 3. This project will now be able to start design in FY 17/18 with construction programmed to begin in FY 20/21.

The California Transportation Commission (CTC) is scheduled to adopt the Augmented 2017 ATP MPO Component Project List at its December 6-7th meeting.

See the table below for a complete list of ATP Cycle 3 and SB 1 Cycle 3 Augmentation Projects.

ATP CYCLE 4

- The Cycle 4 Call-for-Projects will be issued in February/March 2018
- Cycle 4 will cover four (4) programming years: FY 2019/20, 20/21, 21/22, and 22/23
- Cycle 4 will include an additional \$100 million per year from SB1
- A portion of the Cycle 4 Funds may be carried over until the next funding cycle
