ITEM 7 ROAD REPAIR AND ACCOUNTABILITY ACT OF 2017 – SB 1 (BEALL)

Mr. De Haan, VCTC, provided an analysis of the Road Repair and Accountability Act of 2017 including the 1) legislative history, 2) "Fix It First" emphasis, 3) various tax increases, 4) share of funds available to VCTC, 5) Ventura County apportioned shares for rail services, and 6) expansion of the statewide competitive programs.

ITEM 8 SENATE BILL 1 (BEALL) | ATP PROGRAM

Ms. Johnduff, VCTC, stated SB 1 provides an increase of \$100 million annually for the Active Transportation Program (ATP). She said that CTC staff is proposing a 2018 ATP Call for Projects covering the SB 1 funding available in 2017-18 and 2018-19 and that CTC staff recommends making this funding only available to already programmed Cycle 3 projects that can be delivered earlier than currently programmed or for projects that applied for funding in the 2017 ATP but that were not selected for funding. Ms. Johnduff provided the proposed timeline for the 2018 ATP and noted that the item would be considered at the May 17, 2017 CTC meeting.

Discussion

The Committee discussed the project resubmittal process, the CMAQ timeline, and the CTC schedule.

SUBJECT: STATUS OF FEDERAL CONGESTION MITIGATION AND AIR QUALITY

IMPROVEMENT (CMAQ) / SURFACE TRANSPORTATION PROGRAM (STP)

PROJECTS

RECOMMENDATION:

• Review and update project schedules.

DISCUSSION:

Under federal law, Surface Transportation Program (STP) and Congestion Mitigation Air Quality Improvement (CMAQ) funds apportioned to California lapse if they are not used within three years. California apportions CMAQ and part of the STP program to counties with the apportioned portion of the STP still referred to as Regional STP. AB 1012, which became law in October 1999, applies the three-year lapsing rule to CMAQ and STP funds in each county. It is important for VCTC to have an accurate schedule of STP and CMAQ projects to ensure that our county does not lose funds. VCTC also uses this project schedule to ensure that the Federal Transportation Improvement Program (FTIP) includes all of the projects which are ready-to-go. VCTC provides this information to Caltrans which uses it to manage the state's Obligational Authority (OA).

Attached is the schedule of upcoming CMAQ/STP projects showing, in particular, the anticipated Federal Fiscal Year (FFY) 2016/17 schedule. This schedule was updated by TTAC this past April. It should be noted that the Federal Fiscal Year is defined as the period from October 1st to September 30th, and the obligation date is defined as the date that the federal government issues the authorization for a project phase to proceed.

At this time there appears to be no problem with funds lapsing for Federal Fiscal Year 2016/17. There are also sufficient CMAQ projects in the pipeline to obligate the required funds in FFY 2017/18. VCTC anticipates that the environmental work on the Route 101 project will require obligation of several million in additional funds in FFY 2017/18; however, that amount will be insufficient to obligate the required STP funds in next year so VCTC will need to look to "loaning" apportionment to another county, thus resetting the deadline for those funds.

SUBJECT: STP LOAN OF \$6 MILLION TO SAN JOAQUIN COUNCIL OF GOVERNMENTS

RECOMMENDATION:

• Approve \$6 million loan of VCTC's oldest (fiscal year 2015/16) regional Surface Transportation Program apportionments to the San Joaquin Council of Governments (SJCOG), with \$3 million to be repaid at the start of Federal Fiscal Year (FFY) 2017/18, and the remaining \$3 million to be repaid at the start of FFY 2018/19.

BACKGROUND:

The San Joaquin Council of Governments (SJCOG), the regional transportation planning entity for San Joaquin County, has identified the need to borrow \$6 million of Regional STP funds to help expedite one or more ready-to-go projects. There are no funds available to be loaned from other counties in the San Joaquin Valley and so SJCOG is looking elsewhere in the state for a possible source of the loan.

VCTC currently has a \$19.5 million STP balance which will eventually be needed for the 101 and 118 freeway improvement projects, which are VCTC's priorities for use of STP funds. However, for the next two years \$6 million of that balance will not be needed by these projects, so the \$6 million is available to loan for the purpose of expediting ready-to-go projects in San Joaquin County. There are also \$7 million of old city projects for which VCTC programmed STP funds but the projects have not yet been delivered, and the proposed loan will also not affect the VCTC's ability to provide funds for those projects when needed. Staff has confirmed that none of the counties in the SCAG region could benefit at this time from a loan of STP funds.

DISCUSSION

Although the initial interest in the proposed loan was from SJCOG, the loan will also be to VCTC's advantage. AB 1012 stipulates that STP apportionments to each county will lapse if not used within three years of apportionment. VCTC can, however, loan its oldest funds to another county for immediate use and at a future date receive back "new" funds for which the three-year timeclock starts all over. Therefore, the proposed loan to SJCOG will help facilitate VCTC's goal of having an STP balance for use when needed for 101 and 118.

The only risk to VCTC would be that in the event of a severe federal cutback the SJCOG's apportionments would be cut and then the repayment from SJCOG could be delayed. However, the Trump Administration's proposed budget for next year recommends the fully-authorized funding for the Surface Transportation Block Grant Program which is the source for the Regional STP apportionments.

Caltrans Active Transportation Plan:

The Caltrans "Toward an Active California" Plan has been adopted. The plan is designed to complement local and regional active transportation plans being developed across the state. The Plan can be found at: http://www.cabikepedplan.org/app pages/view/190

Implementation: Caltrans will be developing Complete Streets Corridor Plans for their facilities for implementation. In terms of regional facilities, both on-street and parallel facilities are being mentioned in terms of the "complete street network". One goal of the plan is to improve connections between the state's bicycle and pedestrian facilities and local and regional roads, public transit and intercity and passenger rail facilities.

Funding for Implementation: Eligible for funding under the following programs:

- SHOPP
- Congested Corridor Program
- Active Transportation Program (ATP)

<u>2017 – ATP Augmentation Call-for-Projects funded from the Road Maintenance and Rehabilitation Account</u> (SB 1) - \$200 Million Available Statewide:

The CTC has released the Draft 2017 ATP Augmentation Guidelines for SB1 funds available for programming in FY 2017-18 and 2018-19. The draft guidelines can be found on the CTC Website

at: http://www.catc.ca.gov/programs/ATP/2017/Final Draft 2017 ATP Augmentation Guidelines.pdf

Projects from Ventura County which are eligible for this Call-for-Projects include:

- 1. Projects that were awarded funds in the 2017 (Cycle 3) ATP MPO Component which may wish to apply for this funding to advance one or more of their project components into the 2017-18 and/or 2018-19 programming years, or
- 2. Projects on the MPO 2017 ATP contingency list. All of the Cycle 3 projects submitted from Ventura County (which were not awarded funds) are included on the SCAG Contingency List.

Schedule:

- The Draft Guidelines are scheduled to be reviewed and approved at the June 28th California
 Transportation Commission Meeting
- Commission will Issue the Call for Projects on June 30, 2017
- Applications due August 1st, 2017

Supplemental Application materials include the following:

- An Updated Schedule and Funding Plan—Project Programing Request Form
- Signed Authorization Letter from the CEO

Project Selections will be based upon the 2017 (Cycle 3) ATP score and project deliverability. It should be noted that ATP projects must be allocated in the year they are programmed.

Call-for-projects funded by the Greenhouse Gas Reduction Fund (GGRF) - \$10 million available Statewide:

Project Eligibility: Projects eligible for this ATP GGRF Call-for-Projects must have submitted a project application and received a score in the 2017 ATP (Cycle3).

The funds are available for programming in FY 17/18 and 18/19. It should be noted that ATP projects must be allocated in the year they are programmed.
