4. System Update

A. August Newsletter

The newsletter is written for the audience of the growers and contractors who use our program. This issue included "A Simple Process", a story highlighting one employer's simple journey through the Department of Labor's driver approval process. The newsletter also included a request for employers to submit vehicle needs for the upcoming winter months.

B. FY 16-17 Ridership Numbers

The ridership data has been completed and analyzed for the annual fiscal year of 16-17. Reporting results show Passenger Lane Miles increased overall by 4%, with the largest growth in Imperial and Ventura counties.

C. Submittal of support letters to Senate and Assembly offices

Staff continues to educate State officials about the CalVans program. This is in effort to secure Cap and Trade funding to support the growth of the farm labor vanpool program. Staff secured two support letters signed by 30 growers who use our program and 10 Assembly members who are in support of the vanpool programs. Staff awaits news about the determination of funding.

D. Marketing and outreach efforts

Staff continues to attend community and marketing events that are beneficial to the growth and support of CalVans and potential riders. Upon request, staff is available to attend any community events requested.

5. Approve selection of auditing firm

The request for proposal process for selecting an auditing firm has been completed. The highest scoring agency was the firm Dedekian, George, Small & Markarian. Staff is recommending the authorization of this firm for perform our upcoming annual audits.
