# Ventura County Transportation Funding: Tracking Study

Ventura County Transportation Commission VCTC

### Purpose

Compare voter attitudes with 2008 baseline research and assess the feasibility of a supplemental transportation funding measure for the November 2012 ballot.

#### Overview - What We Did

- Review of emerging VCTC comprehensive transportation plan and transit study.
- Public opinion research targeting highfrequency voters.
- Compare 2011 research with 2008 baseline.
- Report results and recommendations.

### Voter Survey

- Telephone survey of 600 high-frequency voters.
- Conducted in late September 2011
- Sample accurately reflects voter universe.
- Approximately 20 minute interview.
- Margin of error of +/- 4.2%
- Compare with similar baseline data compiled in August 2008.

### What We Are Looking For?

- ✓ Need Is transportation a high priority for voters at this time?
- ✓ Affordability Are voters generally confident that they can afford a new tax at this time?
- ✓ Confidence Do voters currently have confidence that tax money will be well spent?

# Sensitivity to tax rate rose from 2008 to 2011



- Awareness of VCTC remains low

## Transportation sales tax support in 2011 stays below 2/3 threshold

### Equivalent gas tax is unpopular

A ten cent gas tax increase raises the same amount of revenue as a $\frac{1}{2}$ cent increase in the sales tax. Which option, if any would you prefer to fund transportation improvements?	Percent

### Findings & Recommendations

#### 1. No ½ cent ballot measure in 2012.

Voter support is not sufficient to place a comprehensive ½ cent 30-year transportation tax measure on the 2012 ballot.

#### 2. Maintain outreach and education.

Strive to maintain ongoing outreach and education efforts to boost engagement and awareness of transportation issues in Ventura County and improve the visibility of the VCTC brand.

#### 3. Use existing resources wisely.

Make the best use of available resources, in light of diminishing state and federal support and SB 716 funding shifts. Focus on delivering costeffective improvement and service priorities that have strong voter and stakeholder support.

#### 4. Focus on future opportunities.

Be prepared to re-evaluate the feasibility of seeking supplemental transportation revenues as economic conditions improve. Consider a shorter term, lower cost measure focused on basic road repair, safety and other related high priority needs.
