# 5. EAST-WEST CONNECTOR UPDATE - VCTC Transit Program Manager Aaron Bonfilio provided an update on the new service which began in November.

The East-West Connector improves access to key employment centers, educational institutions, and health care facilities as well as to the Ventura County Government Center. Somis residents will have the ability to ride the bus to the Ventura County Government Center in time for an 8:00 a.m. jury summons.

Full-priced fare for the East-West Connector is \$1.25; riders eligible for discounted fares pay \$0.60. Discounted fares will also be available for riders who purchase multi-day and multi-ride passes. Free transfers are offered to other VCTC Intercity bus lines as well as local fixed-route providers such as Simi Valley Transit, Moorpark Transit, and Gold Coast Transit.

#### **RECOMMENDATION:**

Receive and file.

#### **BACKGROUND:**

At the September 2017 meeting, CTAC approved the programming of \$6,760,318 CMAQ funds and \$1,228,399 in TDA Article 3 Bicycle & Pedestrian funds (for a total of \$7,988,717) for ten bicycle and pedestrian projects. The Committee also recommended that \$3,240,197 be approved for the Shelf List for three projects that can receive additional funds should they become available. At the October meeting, staff informed the Committee that given a previously-discussed potential change, the total Bicycle & Pedestrian funding had increased to \$8,862,000 due to the rescoring of the Wells Road Bus Stop Improvement program as a pedestrian project and the recommendation to fund that project. It was also mentioned that thanks to availability of \$1,743,000 from Senate Bill (SB) 1, combined with the CMAQ / TDA Article 3, all of the projects submitted for Cycle 3 of the Active Transportation Program would be funded. Without the SB 1 funds, the ATP Cycle 3 process was going to fund \$2,371,000 in Ventura County, so with the addition of SB 1 the total amount of bicycle / pedestrian projects approved last year was nearly \$13 million. Attachment A provides the combined list of projects approved for funding. Attachment B provides the approved Shelf List.

During the past six months, the project sponsors have moved forward with design of the approved projects. The County requested, and TTAC approved, a scope reduction for the Sespe Street Bike Lanes project in the county unincorporated area, resulting in a cost reduction so that project will no longer use the Shelf List balance shown on the \$114,572. Meanwhile, the City of Camarillo has informed VCTC that the Wickford Place to Village Commons Pedestrian/Bicycle project, which received \$190,856 in the 14/15 and 16/17 TDA Article 3 programs, has become infeasible due to the current park agency priorities for that location. Based on the Commission's policy for the Shelf List staff is recommending to the Commission at its May 13<sup>th</sup> meeting that the funds go to top viable project on the Shelf List that can use the funds, which would be the design phase of the Rice Road project in in the unincorporated community of Mira Monte.

Representatives of Thousand Oaks and Ventura County Public Works have indicated they plan to come to the Committee meeting prepared to provide updates on the status of their bicycle/pedestrian projects.

SUBJECT: STATUS OF DISCRETIONARY SB 1 GRANT APPLICATIONS

#### **RECOMMENDATION:**

Receive and file.

#### **BACKGROUND:**

The Road Repair and Accountability Act (SB 1) provides new transportation revenue of which roughly one third is primarily designated for competitive grants. At the December and January meetings the Commission approved VCTC involvement with SB 1 grant applications for a total of \$171,953,000 from two of the competitive grant programs, the Trade Corridor Enhancement Program (TCEP) and the Transit and Intercity Rail Capital Program (TIRCP).

Projects for TCEP are selected by the California Transportation Commission (CTC), and CTC staff has recommended selection of the project VCTC supported, the Rice Avenue Grade Separation. The CTC is scheduled to vote on this staff recommendation at its May 16<sup>th</sup> meeting. TIRCP project selections have been announced by the State Transportation Agency, and VCTC staff has been informed that all of the proposed work in Ventura County is included in the approved funding. The following is a summary of the TCEP and TIRCP funding applications:

- Rice Avenue Grade Separation: Caltrans application for \$68,606,000 from TCEP to provide all the remaining funds required to implement the proposed bridge over the Union Pacific Railroad at Rice Avenue.
- <u>Coastal Express Capital Improvements</u>: Santa Barbara Association of Governments (SBCAG) application for \$9.6 million from TIRCP for Coastal Express Expansion capital improvements in support of the Pacific Surfliner Peak Period Service project.
- LOSSAN Track / Station Improvements: LOSSAN Rail Corridor Agency TIRCP application for LOSSAN North that includes \$31,417,000 for Camarillo Station Pedestrian Undercrossing and double tracking in the vicinity.
- <u>Metrolink Track / Station Improvements</u>: Southern California Regional Rail Authority (SCRRA) systemwide application for TIRCP including \$62,331,000 for Simi Valley Station Platform Extension and double tracking in the vicinity.

It is worth noting that CTC staff is also recommending a combined \$167,880,000 from the Solutions for Congested Corridor Program and TCEP for a SBCAG project for Route 101 Multimodal Corridor Improvements including HOV Lanes between Carpinteria and Summerland.

### **DISCUSSION:**

There was a total of \$2.6 billion in new TIRCP projects announced by STA, for 28 transit agencies including LOSSAN and SCRRA. The TIRCP is enhanced by more than \$240 million annually of SB 1 funding, with the remainder coming from the Cap-and-Trade account. The recommended list for TCEP contains \$1.39 billion statewide for freight movement projects. The estimate for the available TCEP funds includes approximately \$300 million per year from SB 1, with the remaining funds for that program coming from the federal formula freight program that was newly established under the Fixing America's Surface Transportation (FAST) Act passed in 2015. The Solutions for Congested Corridors Program is entirely funded by approximately \$250 million per year from SB 1.
