#### 2. Public Comments

#### 3. Announcements

(Item heard out of order)

Staff introduced Judith Johnduff, VCTC's new Program Analyst. The California Transportation Commission (CTC) Active Transportation Program (ATP) recommendations have been release; no Ventura County projects have been recommended. The Air Pollution Control District (APCD) has released the draft 2015 Triennial Assessment and a Public Hearing will be held on November 10, 2015. The Air Quality Management Plan is in progress and the draft will be available in February 2016.

#### 4. August 20, 2015 Meeting Minutes – Action

Thang Tran noted a correction to item 11 of the August 20, 2015 meeting minutes in that it was Mike Tohidian, not Cliff Finely, who seconded the motion to adjourn the meeting. Mike Tohidian moved to approve the August 20, 2015 meeting minutes, as corrected. Dave Klotzle seconded the motion, which passed with no objection.

#### 5. Caltrans Local Assistance Updates

Local Assistance updates were provided regarding the ATP process, recent HSIP evaluations and obligation schedule as related to the Federal-Aid-Data System (FADS) upgrade this past June as well as the California Road Charge Program, which should be implemented by 2017.

#### 6. Status of Federal STP and CMAQ Projects

Staff provided CMAQ and STP project tables and requested that agencies provide the estimated obligation month and year for each of the projects, as well as the current status of each project. Discussion was had regarding shelf listed projects. A correction to staff's report was noted in that the shelf listed projects are assumed to be programmed when FY2015/16 funds are authorized, not FY2016/17.

#### 7. 2016 State Transportation Improvement Program (STIP) Submittal – Action

Discussion was had on the projected funding for the current STIP cycle. Mike Tohidian moved to recommend, for Commission approval, the 2016 STIP for submittal to the CTC. Jason Samonte seconded the motion. The motion passed with no objection.

#### 8. Future Agenda Items

The ATP Cycle Two Project Approval item will occur in October or November. The City of Oxnard will potentially provide a presentation on the Rice Bridge project at a future meeting. The Congestion Management Program and Bicycle Wayfinding Project will occur as soon as possible.

SUBJECT: ACTIVE TRANSPORTATION PROGRAM (ATP) REGIONAL SCORES

# **RECOMMENDATION:**

• Recommend assignment of points as shown in attachment, resulting in three projects receiving a total of \$3,305,000 in ATP funds.

#### **BACKGROUND:**

During September, the California Transportation Commission (CTC) released its scores for Cycle 2 of the statewide Active Transportation Program (ATP) call for projects. Projects submitted from within Ventura County did not score high enough to warrant award of statewide funds, however because Ventura County is within Southern California Association of Governments (SCAG) region – project applications from the Ventura region were eligible for up to \$3.34 million of available funding from the SCAG region.

SCAG is the agency responsible for scoring remaining projects that did not receive statewide funding. As a result of the CTC scores and the addition of ten points awarded by VCTC, the following project applications will be recommended to the Commission to receive regional funds and become locally programmed.

Based on the recommendation of TTAC, VCTC approved a policy to assign 5 points based on inclusion in local area plans, and 5 points based on inclusion in a Safe Routes to Schools plan.

SUBJECT: STATUS OF FEDERAL STP AND CMAQ PROJECTS

#### **RECOMMENDATION:**

• Review and update project schedules.

### **DISCUSSION:**

Under federal law, STP and CMAQ funds apportioned to California lapse if they are not used within three years. AB 1012, which became law in October, 1999, applies the three-year lapsing rule to CMAQ and STP funds in each county. It is important for VCTC to have an accurate schedule of STP and CMAQ projects to ensure that our region does not lose funds.

VCTC also uses this project schedule to ensure that the Federal Transportation Improvement Program (FTIP) includes all of the projects which are ready-to-go and to manage the county's Obligational Authority (OA). The 2015 FTIP is now federally-approved and VCTC has also gotten approval of amendments for the projects as indicated on this list.

VCTC staff has received some project status information from the local agencies and this information has been included in the spreadsheet provided. Staff requests the Committee review the table and inform staff of any revisions that should be made. It is particularly important to have the correct status information and schedule for projects in the upcoming fiscal year (2015/16). For transit projects that are administered by FTA, the "Planned Obligation" column should contain the date that funds are expected to be transferred to FTA for inclusion in a grant.

SUBJECT: STATUS OF 2017 TRANSPORTATION IMPROVEMENT PROGRAM

# **RECOMMENDATION:**

Receive and file.

### **DISCUSSION:**

Federal law requires that federally-funded transportation projects, as well as regionally-significant projects funded with state and local funds be included in an approved Transportation Improvement Program (TIP). VCTC prepares Ventura County's portion of the TIP for the Southern California Association of Governments (SCAG). The TIP is required to be updated every two years and covers a period of not less than four years. The SCAG 2017 TIP will cover a 6-year period from October 1, 2016 (FY 2016/17) through September 30<sup>th</sup> of 2022 (FY 2021/22).

The first step in drafting the 2017 TIP is to obtain accurate up-to-date information for each project. Therefore, VCTC sent each jurisdiction a request to:

- 1. Update the project information currently listed on the 2015 TIP Project Sheets and,
- 2. Submit new Project Sheets for any new Federally-funded project or new locally funded regionally significant project (except for road rehabilitation projects) through FY 21/22. For TIP purposes, a regionally significant project is defined as a roadway capacity-enhancement located on a freeway or other state highway, or major arterial; or a major new transit center.

We have asked for the information to be submitted to VCTC by **October 23rd**. Once VCTC receives the project information we will enter the data into the SCAG database so that SCAG can start the adoption process.

The current TIP will still be in effect until the adoption of the 2017 TIP, therefore, staff will continue to process project amendments to the current TIP to accommodate changes in funding and project schedules.
