AMENDMENT NO. 2

TO

PROFESSIONAL SERVICES AGREEMENT BETWEEN VENTURA COUNTY TRANSPORTATION COMMISSION

AND

RAILPROS, INC.

This Amendment No. 2 ("Second Amendment") is made as of this <u>7</u> day of <u>June</u>, 2024 ("Effective Date") by and between the VENTURA COUNTY TRANSPORTATION COMMISSION ("VCTC"), and RailPros, Inc. ("Contractor"), (sometimes referred together as the "Parties" and singularly as a "Party").

RECITALS

WHEREAS, VCTC and Contractor entered into an agreement on April 7, 2023 pursuant to which Contractor agreed to provide preliminary engineering, final design, and project management support services related to the Camarillo Americans with Disabilities Act (ADA) Improvement Project ("Agreement"); and

WHEREAS, the Parties desire to amend the Agreement to provide for \$120,000in additional compensation under the Agreement for completion of an additional task by Contractor, which entails preparing an Equivalent Facilitation Request Report for the Project with supporting documentation.

NOW THEREFORE, VCTC and Contractor agree as follows:

- Section 5.1 Compensation and Payment is hereby amended to increase the not to exceed amount under the Agreement by \$120,000 for a new not to exceed amount under the Agreement of \$1,446,367. This additional compensation is based on the hourly rates and fees specified in Attachment 1 "Additional Services Fee Breakdown," plus \$8,798 for contingency. Attachment 1 is incorporated herein by this reference.
- Exhibit A to the Agreement is amended to add an additional task to prepare an Equivalent
 Facilitation Request Report for the Project with supporting documentation in accordance with the
 requirements outlined in Attachment 2 "Additional Scope of Work" attached hereto and
 incorporated herein.
- 3. The costs and scope contemplated in Attachment 1 and Attachment 2 include the costs and work necessary to complete an Equivalent Facilitation Request Report at both the Camarillo and Oxnard rail stations. VCTC may remove the work associated with Oxnard rail station from the Report upon written notice to Contractor. Upon such notice, Contractor will remove such work and issue VCTC a revised statement of costs, which only includes the Camarillo rail station.

Except to the extent amended herein, all other provisions of the Agreement remain in full force and effect.

This Second Amendment may be executed in counterparts and/or by facsimile or other electronic means, and when each Party has signed and delivered at least one such counterpart, each counterpart shall be deemed an original, and, when taken together with other signed counterpart, shall constitute one original, which shall be binding upon and effective as to all Parties.

- Assumes only 1 report will be required to submit to FTA and FRA, which includes 2 stations – Camarillo and Oxnard

- Assume each station will provide the following:
 - Proposed Station layout exhibits
 - Provide 3 to 4 paragraphs of project description summary for their respective design station
 - 1 cross-section for each station
 - Mini high proposed plan view and cross-section
- Assumes others will provide exhibits of the following:
 - Exhibits of the locomotive fleet for both services (ACE and San Joaquins) will be provided by others showing the critical dimensions for the fleet car, interior layout, and ADA-designated area of that car
 - Assume others will provide a picture of the fleet with doors open at existing stations (one for every car type)
- Assume Freight will review and provide the necessary rights and oversize loading constraints that exist on the corridor

1.4 Public Outreach Support

Activities and Deliverables

- Activities:
- All internal public outreach will be completed by VCTC with RailPros support on the content and technical information. All physical signage will be printed and posted by VCTC.
- o Prepare Fact Sheet, Timeline, and 2 Exhibits for Public Outreach
- Establish Regional ADA Group List and provide to VCTC County, LOSSAN, and Metrolink, City. VCTC will lead the effort to send the public meeting notice out to the ADA groups.



- Board Meetings and Support Assumed 3 Meetings, PPT Preparation -Initial Prep, Main Public Hearing, and Finalization.
- Provide website information updates to VCTC.
- o Compile and address public and board comments.

Assumptions and Exclusions

- VCTC will provide all signage material and post them at the regional stations that will go beyond Camarillo and Oxnard. Signage production and postage is excluded.
- VCTC will lead all the public outreach and will be the main contact for the ADA groups as well as the Board presentations. RailPros will provide technical and content support to the Public Outreach. Public Outreach support can be scoped at VCTC's request.
