# Overall Disadvantaged Business Enterprise Goal and Methodology Federal Fiscal Years 2025 – 2027

#### I. Summary

On September 7, 2021, the Ventura County Transportation Commission (VCTC) adopted an Overall Disadvantaged Business Enterprise (DBE) goal of 3.57% for federally funded transit project contracts scheduled to be awarded in federal fiscal years (FFYs) 2022 – 2024. The overall goal of 3.57% consisted of a race- and gender-neutral goal of 1.48% and race- and gender-conscious goal of 2.09%. The DBE goal applies to VCTC and its five sub-recipients: City of Camarillo, City of Ojai, City of Oxnard, City of Thousand Oaks and the Area Agency on Aging. Because the current program expires on September 30, 2024, VCTC has developed a proposed new Overall DBE Goal for the next three-year period that begins October 1, 2024, and ends September 30, 2027.

Based on information described in this report, VCTC should consider the following:

- Adopt an Overall DBE Goal of 1.34% for FFYs 2025 2027.
- Use narrowly tailored DBE contract goals to help meet the proposed Overall DBE Goal for FFYs 2025 – 2027.
- Set the race- and gender-neutral goal at 0.65% and the race- and gender-conscious goal at 0.69% (total of 1.34%) for FFYs 2025 2027.

#### II. Background

The United States Department of Transportation (USDOT) requires recipients of USDOT funds to establish DBE goals to ensure that small, disadvantaged business enterprises (DBE) can compete fairly for federally funded transportation-related projects. FTA requires the development of an overall triennial DBE goal when FTA funding recipients anticipate awarding more than \$250,000 in FTA funds in prime contracts (excluding transit vehicle purchases) in a federal fiscal year. Because VCTC serves as the designated recipient of federal transit funds for VCTC and the cities of Camarillo, Ojai, Oxnard, Thousand Oaks and the Area Agency on Aging, VCTC is required to adopt a triennial DBE Goal.

USDOT has established a two-step process to assist funding recipients to calculate the DBE goal<sup>1</sup>. Step 1 of the goal setting process is to estimate the relative availability of DBEs

to perform the types of contracts that VCTC and its sub-recipients intend to award. In other words, the analysis is an attempt to estimate the percentage of DBEs firms that are ready, willing and able to compete for DOT-assisted funded contracts. Step 2 of the goal setting calculation process is intended to adjust the base figure calculated in Step 1 to make it as precise as possible. Under the rule, all evidence available should be used to determine whether such an adjustment is necessary. If the evidence does not suggest such an adjustment is necessary, then no adjustment should be made.

### III. DBE Goal Setting Methodology

As noted in section II (Introduction), the DBE goal was calculated using the two-step process described in the "Tips for Goal Setting" guidance provided by USDOT. In Step One a Base Figure was calculated that shows the relative availability of DBEs by dividing the number of DBE firms that are ready, willing, and able to compete for project contracts by the number of all firms (DBEs and non-DBEs) ready, willing and able to compete for project contracts. The calculation is summarized in the equation below:

$$Step \ One \ Base \ Figure = \frac{Ready, willing \ and \ able \ DBEs}{All \ ready, willing \ and \ able \ businesses}$$

$$(Including \ DBEs \ and \ Non - DBEs)$$

In Step Two the Base Figure was analyzed to determine if it requires adjustment upward or downward or left as is. Step One is described in more detail in section IV, and Step Two is described in section V.

## IV. Step One: Calculating the Base (DBE Goal) Figure

Six separate activities were conducted to complete Step One:

- a) Determine the Local Market Area.
- b) Develop a list of federal transit projects scheduled to be awarded in FFYs 2025 27.
- c) Assign North American Industry Classification System (NAICS) codes to projects.
- d) Obtain the number of DBE firms ready, willing and able to compete for projects contracts in FFYs 2025 27.
- e) Obtain the number of all firms (DBEs and non-DBEs) ready, willing and able to compete for project contracts in FFYs 2025 27.
- f) Calculate the relative availability of DBEs and the Weighted Base Figure which represents the final calculation for Step One.

#### IV (a) The Local Market Area

The boundaries of the local market area were determined based on where most of the companies that submitted bids and awarded contracts in past years were located. Bidder and awardee data from FFYs 2011/12 through 2022/23 were used to determine the local market area (see Bidder's List in Attachment 1). Firms were counted only once

even if they submitted more than one bid and/or were awarded more than one contract over the years. As with previous programs, the local market area was determined to be Ventura and Los Angeles counties since 59.1% of the firms are in these two counties. Table 1 summarizes the location of the firms.

#### IV (b) Projects Scheduled for Award in FFYs 2025 – 2027

Table 2 lists the federal transit projects scheduled to be awarded in FFYs 2025 - 2027. The total amount of funds assigned to these projects is \$35,752,000. Dollar amounts listed in the table represent federal funds only. Other project funds are excluded as per federal guidelines.

Subcontracting opportunities for VCTC's Camarillo Metrolink Station ADA Improvements project are listed in Table 3a on the next page.

Projects were further aggregated by NAICS Code Industry as presented in Table 4 to assist with the analysis.

#### IV (d) DBE Firms Ready, Willing and Able to Compete for Contracts

DBE firms ready, willing and able to perform the anticipated work were identified using the California Unified Certification Program (CUCP) Statewide DBE Directory<sup>3</sup>. NAICS Codes were used to identify DBE firms that indicated their willingness to work in the Local Market Area (Ventura and Los Angeles counties) and able to perform the proposed work. A total of 977 DBE firms were identified by NAICS code and presented on Table 5. Names and addresses of the DBE firms are provided in Attachment 2 titled "DBE Directory."

#### IV (e) All Firms (Non-DBEs and DBEs) Ready, Willing and Able to Compete for Contracts

The total number of all firms (including DBEs) ready, willing and able to perform the anticipated contracts by NAICS code was obtained from the U.S. Census Bureau.<sup>4</sup> A total of 34,500 firms located within the Local Market Area were identified as presented in Table 6. Because the Census Bureau data is based on the 4-digit NAICS code industry group, the DBE data presented in Table 5 is also based on 4-digit NAICS codes.

#### IV (f) Relative Availability of DBE Firms and Weighted Base Figure

Step 1 of the goal setting process is to estimate the percentage of DBEs firms that are ready, willing and able to compete for DOT-assisted funded contracts by calculating the:

- 1. Weight of each type of work by NAICS Code.
- 2. Relative availability of DBEs by NAICS Code.
- 3. Weighted availability Base Figure.

Table 7 presents the weight of each work type based on NAICS code and federal funds assigned to projects. Transit operations account for 75.3% of total federal funds.

U.S. DOT further recommends that DBE availability be weighted by the amount of federal funds assigned to projects to improve the accuracy of the Base Figure calculation. The weighted availability of DBEs is estimated at 2.32% as presented in Table 9 which is a slight reduction from the unweighted estimate of 2.83%. The weighted base figure is less than the existing DBE Goal weighted base figure of 5.0% because: bus operations accounts for a greater percentage of the federal funds (79.85%) when compared to the currently adopted DBE program (49%); and there are only two available DBE bus operators.

### I. Step Two: Adjusting the Base Figure as Needed

Step Two of the DBE goal setting process is to evaluate the weighted estimate calculated in Step One to determine if the Base Figure requires further refinement. The following factors were considered as part of the Step Two evaluation process:

- a) Past participation of DBEs in contract awards including the median participation of DBEs in the previous five years.
- b) Comparing proposed projects to previously awarded contracts, Bidder's List and the DBE Directory to estimate DBE participation in the following three-year period based on race- and gender-neutral measures.
- c) LA Metro Disparity Study conducted in the Local Market Area including marketplace conditions.
- d) Data on employment, self-employment education and training, and union

apprenticeship programs in the Local Market Area.

#### V (a) <u>Past Participation of DBEs</u>

The actual percentage of federal funds awarded to DBEs in FFY 2020, 2021 and 2022 is presented in Table 10. U.S. DOT recommends using the median (calculated by taking the "middle" value) to estimate past participation of DBEs; therefore, past participation is calculated at 1.34%. Data in Table 10 represent revisions to previously submitted reports to U.S. DOT reports to conform with Triennial Review findings that changed the reporting of DBE participation to the year that contracts are awarded rather than when funds are utilized. DBE participation in FFY 2020 was obtained through race- and genderneutral measures, and DBE participation in FFY 2021 was obtained through race- and gender-conscious measures.

#### V (b) Comparing Proposed Projects with Projects Awards in Past Years

Projects proposed for funding in the next three years (Table 2) were compared with project contracts awarded in recent years of similar work type to estimate DBE participation based on race- and gender-neutral measures. Data for the analysis was obtained from agency contract awards, Bidder's List (Attachment 1), and the DBE Directory (Attachment 2) for similar projects.

Table 11 summarizes the results of the analysis which <u>estimates DBE participation at 0.65%</u> based on race- and gender-neutral measures (no contract goals).

### V (c) <u>LA Metro Disparity Study</u>

The Los Angeles County Metropolitan Transportation Authority (LA Metro) completed a disparity study<sup>6</sup> to evaluate whether person of color (POC)- and woman-owned businesses face any barriers in the Los Angeles County Metropolitan Transportation Authority (LACMTA's or Metro's) construction, professional services, and nonprofessional services and goods contracts and procurements. The disparity study examined whether there are any disparities, or differences between:

• The percentage of contract and procurement dollars Metro awarded to POCand woman-owned businesses during the study period, which was January 1, 2016 to December 31, 2021 (i.e., utilization, or participation); and

 The percentage of contract and procurement dollars one might expect Metro to award to POC- and woman-owned businesses based on their availability to perform specific types and sizes of Metro contracts and procurements (i.e., availability).

The purpose of the disparity study was to assess whether any disparities exist between the participation of POC- and woman-owned businesses in Metro work and the availability of those businesses for that work.<sup>7</sup>

The report explains that if Metro determines that it is appropriate to use race- and gender-conscious measures to address substantial disparities (e.g., awarding individual contracts and procurements with the use of POC- and woman-owned business participation goals), then the agency can rely on information from the disparity study to help ensure its use of such measures adheres to the strict scrutiny and intermediate scrutiny standards of constitutional review, respectively.<sup>8</sup>

The study found that most POC-owned business groups showed substantial disparities for many of the contract and procurement sets shown in Table 12 with the exception of Black American-owned businesses. Black American-owned businesses showed substantial disparities for all work considered together, as well as for prime contracts, for professional services projects, and for non-USDOT funded work, but did not show substantial disparities for any other projects sets presented in Table 12. Similarly, white woman-owned businesses showed substantial disparities for prime contracts, professional services projects, and non USDOT-funded work, but did not show substantial disparities for any other project sets presented in Table 12. Substantial disparities indicate inferences of discrimination against relevant POC- and woman-owned business groups in the Los Angeles County marketplace and as part of Metro's contracting and procurement.9

An analyses of marketplace conditions in Los Angeles County conducted as part of the study indicate that POCs and women face various barriers in industries relevant to Metro's contracting and procurement. Existing research and primary research conducted "indicate that disparities exist in acquiring human capital, accruing financial capital, owning businesses, and operating successful businesses. In many cases, there is evidence those disparities exist even after accounting for various personal and business factors. There is also evidence that many disparities are due—at least, in part—to race- or gender-based discrimination. Barriers in the marketplace likely have important effects on the ability of POCs and women to start businesses in relevant industries—construction, professional services, goods and other services, and transit services—and to operate those businesses successfully. Any difficulties those individuals face in starting and operating businesses may reduce their availability for government work and the degree to which they are able to successfully compete for such projects."

# V (d) <u>Data on employment, self-employment education and training, and union apprenticeship programs</u>

#### Employment

Table 13 presents the annual number of persons employed in Ventura and Los Angeles counties from 2013 to 2023. The data shows that both counites enjoyed a steady growth in annual employment from 2013 to 2018, with both counties experiencing a significant drop in employment in 2020 during the COVID 19 Pandemic. The number of employed grew in 2021 and 2022 in both counties but the number of persons employed in 2023 remains lower than 2019 before the Pandemic.

The 2019 Caltrans FTA Disparity Study investigated whether race/ethnicity or gender affects rates of self-employment (business ownership) among workers in the local transit-related professional services and goods and services industries. The analyses revealed that, even after accounting for various race- and gender-neutral characteristics:

- Being Black American, Asian Pacific American, Subcontinent Asian American, or Hispanic American was associated with lower rates of business ownership than being non-Hispanic white in the professional services industry. Being a woman was also associated with lower rates of business ownership than being a man in the professional services industry; and
- Being Black American or Hispanic American was associated with lower rates of business ownership than being non-Hispanic white in the goods and services industry.<sup>13</sup>

#### II. Proposed DBE Goal for FFYs 2025 – 2027

Based on the information in Section V (Step Two Adjustment), VCTC should consider the following:

- Adopt an Overall DBE Goal of 1.34% for FFYs 2025 2027 based on the median past participation of DBEs presented in Table 10. The weighted Base Figure of 2.32% calculated in Table 9 appears too high given the limited availability of DBE's available to perform the type of work to be awarded in the next three years (including bus operations that comprise 80% of total federal funds), past participation of DBE's, and limited subcontracting opportunities estimated at \$450,000 over the three-year period.
- Use narrowly tailored DBE contract goals to help meet the proposed Overall DBE Goal for FFYs 2025 2027.

Set the race- and gender-neutral goal at 0.65% and the race- and gender-conscious goal at 0.69% (total of 1.34%). The race-and gender-neutral goal of 0.65% is based on projected race- and gender-neutral participation of DBEs for the next three years calculated in Table 11. The race- and gender-conscious goal of 0.69% was derived by subtracting the race-and gender-neutral goal of 0.65% from the median DBE past participation figure of 1.34% (1.34% - 0.65% = 0.69%).

Federal regulations require that grant recipients meet the maximum feasible portion of the overall DBE Goal through race- and gender-neutral measures.<sup>14</sup> Federal rules also require that contract goals be established to meet any portion of the overall DBE Goal that cannot be met through race- and gender-conscious measures alone. The following provisions apply to the use of contract goals:

- Contract goals may only be used on contracts that have subcontracting possibilities.
- Contract goals are not required on every project.
- The goal for a specific contract may be higher or lower than the percentage of the Overall Goal depending on such factors as the type of work involved, the location of the work, and the availability of DBEs for the work of the particular contract. However, over the period covered by the Overall Goal, grantees must set contract goals so that they will cumulatively result in meeting the portion of the overall goal projected not to be met through the use of race-neutral measures.
- Contract goals must provide for participation by all certified DBEs and must not be subdivided into group-specific goals.
- If during the course of any year in which contract goals are used it is determined
  that the Overall Goal will be exceeded, the use of contract goals must be
  reduced or eliminated to the extent necessary to ensure that the use of contract
  goals does not result in exceeding the Overall Goal. Conversely, if it is determined
  that the Overall Goal will not be met, then appropriate measures need to be
  taken to meet the Overall Goal.
- Contractors can meet DBE Goals by either making commitments at the time of bid to include certified subcontractor DBEs at the contract goal amount or by showing they made all reasonable good faith efforts when not being able to meet contract goals.

Federal law requires that DBE programs that include race- and gender-conscious measures meet the **strict scrutiny** standard of constitutional review. The LA Metro 2017 Disparity Study provides a good description of the strict scrutiny standard:<sup>15</sup>

"Strict scrutiny standard. An agency must meet both the compelling

<u>governmental interest</u> and the <u>narrow tailoring</u> components of the strict scrutiny standard. A program that fails to meet either component is unconstitutional.

Compelling government interest. An agency must demonstrate a compelling governmental interest in remedying past identified discrimination in order to use race- or gender-conscious measures. An agency that uses race-or gender-conscious measures as part of a minority-or woman-owned business program has the initial burden of showing evidence of discrimination – including statistical and anecdotal evidence – that supports the use of such measures. Agencies cannot rely on national statistics of discrimination in an industry to draw conclusions about the prevailing market conditions in their own regions. It I not necessary for a government agency itself to have discrimination against minority- or woman-owned businesses for it to act.

Many agencies have used information from disparity studies – specifically, evidence of disparities between the participation and availability of minority- and women-owned businesses – as part of determining whether their contracting practices are affected by race- or gender-based discrimination.

**Narrow tailoring**. In addition to demonstrating a compelling governmental interest, an agency must also demonstrate that its use of race- and gender-conscious measures is narrowly tailored. There are a number of factors that courts consider when determining whether the use of such measures is narrowly tailored including:

- The necessity of such measures and the efficacy of alternative, raceand gender-neutral measures;
- The degree to which the use of such measures is limited to those groups that actually suffer discrimination in the local marketplace;
- The degree to which the use of such measures is flexible and limited in duration, including the availability of waivers and sunset provisions;
- The relationship of any numerical goals to the relevant business marketplace; and
- The impact of such measures on the rights of third parties."

Because Los Angeles County is part of the Local Market Area for the DBE Goal setting process, it is proposed that the results of the LA Metro Disparity Study be used to meet the compelling government interest scrutiny standard for using DBE race- and gender-conscious goals as part of VCTC's FFYs 2025 – 2027 DBE program.

It is further proposed that the *narrow tailoring* component of the scrutiny standard be met through the following measures:

• Limit contract goals to projects with subcontracting opportunities. VCTC staff would work with local agency grant recipients (subgrantees) to identify and select the projects that would include contract goals and the goal amounts.

- Limit contract goals to groups that suffer discrimination in the Local Market Area. Subcontracting opportunities listed in Table 3a are consistent with the type of contracts that the Metro Disparity Study identified as having disparities (construction and subcontracts as shown in Table 12).
- Flexible measures and limited duration. The proposed use of contract goals described in this report is limited to FFYs 2025 2027. Contract goals would vary to help meet the DBE Goal and would only apply to projects with subcontracting opportunities.
- Numerical goals developed based on the relevant business marketplace. The proposed overall DBE goal of 1.34% is based on the weighted availability of DBE's in the marketplace for the specific projects proposed in FFYs 2025 2027. The raceand gender-neutral goal of 0.65% is based on historical DBE participation for the type of projects proposed in FFYs 2025 2027, and the race- and gender-conscious goal of 0.69% is the difference between the Overall DBE Goal of 1.34% and the race-and gender-neutral goal of 0.65%.
- DBE contract goals and the rights of third parties. If a bidder on a prime contract
  cannot find sufficient certified DBE participation to meet a contract goal, the
  bidder can still be awarded the contract by documenting its good faith efforts to
  find DBE participation.

#### III. Public Notice and Consultation Process

As part of the DBE goal setting process, VCTC is required to consult with persons and groups to obtain information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and VCTC efforts to establish a level playing field for the participation of DBEs. NOTE: This section to be completed after the consultation process has been completed.
